NOTIFICATION

New Delhi, the 28th October, 2014

G.S.R. 758(E).— In exercise of the powers conferred by section 32 of the Metro Railways (Operation and Maintenance) Act, 2002 (Act 60 of 2002), the Central Government hereby makes the following rules, namely:-

1. Short title and commencement.-(1) These rules may be called the Chennai Metro Railway (Carriage and Ticket) Rules, 2014.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. Definitions.-(1) In these rules, unless the context otherwise requires,

(a) "Act" means the Metro Railways (Operations and Maintenance) Act, 2002 (60 of 2002);

(b) "Authorized" means authorized by metro railway administration.

(2) Words and expressions used in these rules and not defined, but defined in the Act, shall have the same meanings & assigned to them in the Act.

3. Carriage of goods or luggage.- No person shall, while travelling in Metro Railway, carry with him any goods other than baggage containing personal belongings not exceeding 60 centimetre x 40 centimetre x 25 centimetre in size and 15 kilogram in weight, except with the prior approval of the metro railway administration.

4. Prohibition against carriage of dangerous and offensive goods.- (1) No person shall take or cause to be taken on the Metro Railway the following dangerous materials, namely:-

(a) Explosive substances which possess risk of explosion or fire or both;

(b) gases compressed, liquefied or dissolved under pressure;

(c) petroleum and other inflammable liquids;

(d) inflammable solids;

(e) oxidizing substances;

(f) poisonous (toxic) substances;

(g) acids and other corrosives;

(h) radio active substances;

(i) weapons, arms and ammunitions; and

(j) any other article declared as dangerous material by the metro railway administration from time to time.

(2) No person shall take or cause to be taken on the metro railway the following offensive materials, namely:-

- (a) Blood dried or coagulated or decomposed, whether human or animal, except packed and covered fresh human blood for medical exigency;
- (b) any blood stained material or object except an accident victims with blood stained clothes;
- (c) corpses;
- (d) carcasses of dead animals;
- (e) bones, excluding bleached and cleaned bones;
- (f) fertilizer or Manure;
- (g) rags, including oily rags;
- (h) any decayed animal or vegetable matter;
- (i) human ashes;
- (j) human skeleton;
- (k) parts of human body; and
- (l) any other article declared as offensive material by the metro railway administration from time to time.

- (3) No person shall take or cause to be taken on the Metro Railway live animals and birds. However, security person on duty may take along sniffer dogs for the purpose of security.
- (4) If any official of metro railway has reason to believe that any person is carrying with him, in a container of any form, or otherwise, any dangerous or offensive material, he may cause such container to be opened by its carrier for the purposes of ascertaining its contents.
- (5) Any official of metro railway may remove from the metro railway any person taking with him any dangerous or offensive material.

5. Notwithstanding anything contained in these rules, the members of the Armed Forces of the Union Government, the State Police, the Para-military forces, the National Cadet Corps, and other uniformed forces of the Central Government, State Governments or the Union Territories, while on metro railway in the course of their duty, may carry the authorized weapons, arms and ammunition.

6. Application of other Acts and rules.-(1) Nothing in these rules shall be deemed to detract from the operation of:-

- (a) Explosives Act, 1884 (Act 4 of 1884);
- (b) Explosives Rules, 1983;
- (c) The Arms Act, 1959 (Act 54 of 1959); and
- (d) The Arms Rules, 1962.

(2) Nothing in these rules shall prevent carrying of one piece of safety match box or a pocket cigarette gas lighter by a metro railway passenger.

7. Diseases declared to be infectious and contagious.— No person suffering from any infectious or contagious diseases including the following, shall travel by the metro railway, namely:—

- (a) Cerebra-Spinal meningitis;
- (b) chicken-pox;
- (c) cholera;
- (d) diphtheria;
- (e) measles;
- (f) mumps;
- (g) scarlet fever;
- (h) typhus fever;
- (i) typhoid fever;
- (j) whooping cough; and
- (k) any other disease declared as contagious and highly infectious by Central or State Government.

Provided that a closed (non-infective) leprosy patient carrying a certificate from a registered medical practitioner certifying him to be non-infective may travel by the metro railway.

8. Particulars of ticket.—(1) Any person desirous of travelling on the metro railway shall, upon payment of fare, be issued with a ticket by the metro railway administration or an agent authorized in this behalf. For such travel, he shall be governed by the Business Rules of Metro Railway Administration.

(2) The ticket issued under sub-rule (1) shall be of the following types, namely:—

- (a) Single journey ticket, which can also be contactless smart tokens or paper contactless smart cards;
- (b) stored value cards, valid for the period as authorized;
- (c) Group Ticket for group journey as authorized;
- (d) any other ticket as authorized in the Business Instructions published by metro railway administration from time to time.

सा.का.नि. 759 (अ)—केंद्रीय सरकार, मेट्रो रेल (प्रचालन और अनुरक्षण) अधिनियम, 2002 (2002 का 60) की धारा 47 द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए निम्नलिखित नियम बनाती है, अर्थात् :—

1. **संक्षिप्त नाम और प्रारंभ**—(1) इन नियमों का संक्षिप्त नाम चेन्नई मेट्रो रेल (वहन और टिकट) संशोधन नियम, 2018 है।
 2. ये राजपत्र में उनके प्रकाशन की तारीख को लागू होंगे।
2. चेन्नई मेट्रो रेल (वहन और टिकट) नियम, 2014 में नियम 7 के परंतुक का लोप किया जाएगा।

G.S.R. 839(E).—In exercise of the powers conferred by section 32 of the Metro Railways (Operation and Maintenance) Act, 2002 (60 of 2002), the Central Government hereby makes the following rules to amend the Chennai Metro Railway (Carriage and Ticket) Rules, 2014, namely:-

1. Short title and commencement.-(1) These rules may be called the Chennai Metro Railway (Carriage and Ticket) Amendment Rules, 2018.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. In the Chennai Metro Railway (Carriage and Ticket) Rules, 2014, the proviso to rules 7 shall be omitted.

G.S.R. 601(E).—In exercise of the powers conferred by section 32 of the Metro Railways (Operation and Maintenance) Act, 2002 (60 of 2002), the Central Government hereby makes the following rules to amend the Metro Railways (Carriage and Ticket) Rules, 2014, namely:-

1. **Short title and commencement.**- (1) These rules may be called the Metro Railways (Carriage and Ticket) Amendment Rules, 2019.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. In the Metro Railways (Carriage and Ticket) Rules, 2014, for rule 3, the following rule shall be substituted, namely:-

“3. **Carriage of goods or luggage.**- (1) No person shall, while travelling in metro railway, carry with him any goods other than one baggage containing personal belongings not exceeding 80 centimetres x 50 centimetres x 30 centimetres in size and 25 kilograms in gross weight, except with prior approval of the metro railway administration. Baggage in form of bundles is not permitted.

(2) In case of a dedicated metro line for airport connection, no person shall, while travelling in metro railway, carry with him any goods other than two baggages containing personal belongings not exceeding 90 centimetres x 75 centimetres x 45 centimetres in size and 32 kilograms in gross weight, except with prior approval of the metro railway administration. Baggage in form of bundles is not permitted”.

G.S.R. 395(E).—In exercise of powers conferred by section 32 of the Metro Railways (Operation and Maintenance) Act, 2002 (60 of 2002), the Central Government hereby makes the following rules, further to amend the Metro Railways (Carriage and Ticket) Rules, 2014, namely: -

1. (1) These rules may be called the Metro Railways (Carriage and Ticket) Amendment Rules, 2023.
(2) They shall come into force on the date of their publication in the Official Gazette.
2. In the Metro Railways (Carriage and Ticket) Rules, 2014, in rule 4, in sub-rule (2), after clause (g), the following proviso shall be inserted, namely:-

Provided that a person duly authorised in this behalf by a hospital registered under the Transplantation of Human Organs and Tissues Act, 1994 (42 of 1994), may take along, human organs or tissue or both, for the purpose of organ or tissue transplant.
